License and Usage. Snowflakes in Stanthorpe agrees that the sponsor's information will be used only in connection with the 2017 Event to provide the benefits set forth in the Proposal and such other benefits as Sponsor and Snowflakes in Stanthorpe may agree.

Sponsor Understandings. No portion of the sponsorship cash payment or in-kind services are subject to being refunded for any reason except governed by Snowflakes in Stanthorpe. Sponsorships are not exclusive unless otherwise stated in the proposal.

Termination. Snowflakes in Stanthorpe may terminate this contract on 30 days written notice. In the event of termination for any reason other than failure to provide contracted fees or services, Snowflakes in Stanthorpe may substitute an event with equivalent benefits with the approval of the Sponsor or shall refund any cash fee received from Sponsor by Snowflakes in Stanthorpe. Sponsor shall not terminate this agreement without the approval of Snowflakes in Stanthorpe.

Amendments. This agreement may be amended only by a written instrument executed by both parties.
